## PRIORITIES FOR SOC 2 COMPLIANCE PREPAREDNESS

Developed by the American Institute of CPAs (AICPA), Service Organization Control (SOC) 2 defines criteria for managing customer data based on five trust service principles:

**SECURITY | AVAILABILITY | PROCESSING INTEGRITY | CONFIDENTIALITY | PRIVACY**

SOC 2 certification is issued by outside auditors who perform auditing procedures on service providers to ensure they securely manage data to protect the interests of their customers. Mishandled data can leave organizations vulnerable to attacks, such as data theft, extortion and malware installation. For security-conscious businesses, SOC 2 compliance should be a minimal requirement when considering application and network security providers.

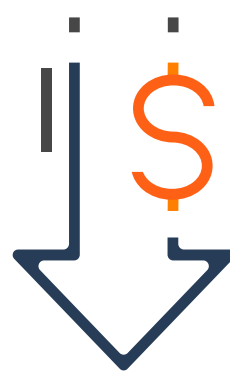

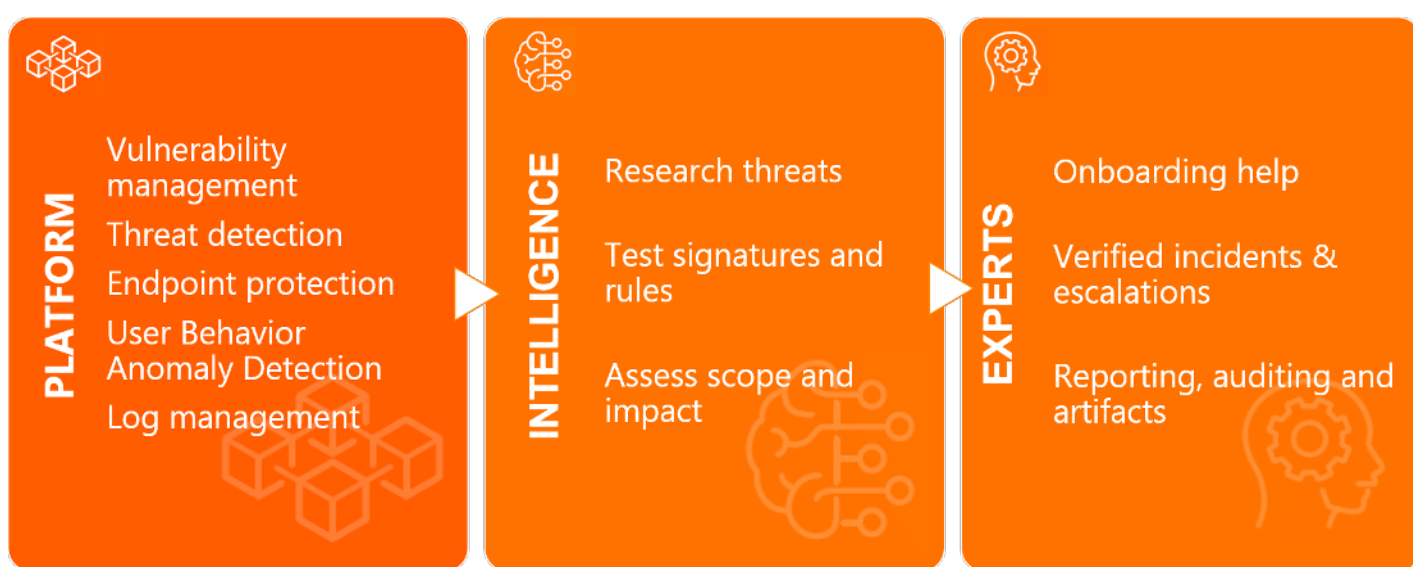
